The technical control of the project (including both the centers) shall rest with the Head, Department of Agronomy, MPKV, Rahuri. The overall control of the project (including both the centers) shall rest with Director of Research, MPKV, Rahuri.


The outcome of the execution shall be comprehensively evaluated at the Directorate level and the evaluation report shall be submitted along with the annual AUCs.


