- In case, if the item/material supplied to be defective at a later stage, the same shall be replaced immeditiately at free of cost.
- The invoice shall contain the break-up of GST and should reflect the same price mentioned in the quotation. 9.
- 100% payment shall be made against delivery of material in good condition.
