The applications are invited from eligible candidates for recruitment of "Skilled Helper" purely on temporary basis on pay structure given by Government of Maharashtra in the Ad-hoc project entitled "Developing moisture stress (drought) and salinity tolerant sugarcane genotypes for Maharashtra" sanctioned by the Government of Maharashtra for the period of 2023-24 to 2025-26 (3 years) at Central Sugarcane Research Station, Padegaon, Tal. Phaltan, Dist. Satara.

The said post is to be, filled purely on contractual basis up to 31st March, 2026 for a tenure of six month period with following pay and essential qualifications as prescribed by Government of Maharashtra as given below.

TERMS AND CONDITIONS


1. Appointment is of **purely on temporary basis and six months** subjected to the termination or closing of the ad-hoc project (31/03/2026).
2. The candidate will have to apply on plain paper giving full details as per enclosed proforma along with attested xerox copies of requisite documents and submit the same to the **Sugarcane Specialist, Central Sugarcane Research Station, Padegaon, Tal. Phaltan, Dist. Satara (M.S.)**.
3. Last date for submission of application is **21/02/2025**. Applications received after due date will not be entertained.
4. The selection committee will interview only eligible candidates. It is responsibility of applicant to attend in person / online interview on schedule date and time at their own cost as communicated by email/text message/whats app message.
5. If candidates are more, written test or the committee's decision will be taken for screening the candidates and after screening selected candidates will be interviewed by the selection committee.
6. The candidate should bring photo identity which needs to be produced during the "Verification of Document" process or Interview. No TA/DA will be paid for attending the interview
7. The selected candidate will be required to give an undertaking that he/she will not leave the assignment half way and shall complete the work in the prescribed time limit. In this

regard the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per University rules.

8. The selected candidates will have to work at Central Sugarcane Research Station, Padegaon, Tal. Phaltan, Dist. Satara in the field/laboratory and office as per the mandate of the ad-hoc project for the entire term as full time worker and they will not be allowed to accept any other appointment/assignment during this period. He/She should have to perform all duties concerned with the project and **any other duties assigned by the Project Investigator from time to time.**
9. The selected candidates will hold responsible all the instruments related to the project during his/her tenure period.
10. The appointment of the selection committee for the said post shall be tenure appointment and purely on temporary basis (6 month) and likely to be terminated at any time without assigning any reason thereof; **therefore the candidate shall not have any right of claiming permanency benefit of said post or such post by virtue of this contractual appointment in the University or State Government.**
11. The Notification does not mean that the post will be necessarily filled. The discretionary power will rest with the selection committee constituted for the purpose. The appointment of candidate will decide by selection committee only for the period of six month. After completion of six month period there is compulsory break period of 15 days or further approval of reappointment received from University competent authority.
