NOTIFICATION

Applications are invited from the eligible candidates for the post **Skilled Labour-Tractor Driver** purely on temporary and contractual basis in the Revolving Fund for Self-Sustainable Functioning of “**Climate Smart Agriculture Research-cum-Demonstration Block (CSARDB)**”, Department of Agricultural Engineering, MPKV, Rahuri. The interested candidates are encouraged to apply in the prescribed format (provided in this notification) by sending completely filled in application form and self-attested copies of certificates/material/documents by post or courier service or in person to CSARDB project old CAAST-CSAWM Office Building, Department of Agricultural Engineering, MPKV, Rahuri so as to reach on or before **14/02/2025 (upto 6.00 pm)**.

The postal address is: Principal Investigator, Climate Smart Agriculture Research-cum-Demonstration Block (CSARDB), old CAAST-CSAWM Building, Department of Agril. Engineering, Mahatma Phule Krishi Vidyapeeth, Rahuri, Dist; Ahilyanagar-413722 (MS).

The applications will be scrutinized for the eligibility, only short-listed candidates will be called for the interview. No additional documents other than those submitted with the application will be accepted separately either before the last date, after the last date; or at the time of document verification and interview.

The date of interview will be communicated to eligible candidates separately by email/text message. However, the candidates are also advised to visit regularly the website "**www.mpkv.ac.in**" for any updates.

The Upper age limit will be 40 years for men and 45 years for women for the above posts.

Conditions


- a) It is the responsibility of the candidate to submit the application and to attend the interview on scheduled date and time as communicated by email/text message.
- b) The post is purely on a temporary basis for the specified period and the candidate is subjected to termination on the expiry of the period or the project "CSARDB" or by giving the notice of one month from either side.
- c) Canvassing in any form will make the candidate ineligible.
- d) The candidate should bring photo identity which needs to be produced during the "Verification of Document" Process or interview.
- e) It is to inform to note all the terms and conditions of the temporary employment as stated below.

Terms and conditions:

1. The Skilled Labour-Tractor Driver will be under the administrative control of the concerned Co-Principal Investigator (Co-PI) and Principal Investigator (PI).
2. The engagement/appointment will stand terminated on completion of the tenure of the scheme or on the date stated in the appointment order whichever is earlier; whether so communicated formally on an individual basis or not. The University (MPKV) or this project (CSARDB) holds no responsibility for regularization/ appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporary; time-bound arrangement on contractual and co-terminus basis with the project.
3. The Skilled Labour-Tractor Driver shall have no legal right to claim his/her regularization/ appointment by absorption or otherwise against any regular posts or any further contractual engagement on termination of this Project. The engagement in the scheme is purely time-bound, non-regular and on co-terminus basis with the Project. The services of the incumbent shall stand terminated automatically on expiry of the project/appointment order whichever is earlier.
4. If any Skilled Labour-Tractor Driver leaves his/her assignment without permission for one month, he/she will stand terminated from the date of his/her absence.
5. The appointment of Skilled Labour- Tractor Driver will be terminated at any time by the issue of 24 hours' notice if the Skilled Labour-Tractor Driver found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct or of discipline.
6. Skilled Labour-Tractor Driver will not leave the project in the middle of his/her tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month's salary. Alternatively, CSARDB, MPKV can terminate the services of Skilled Labour-Tractor Driver by giving one month notice by citing no reasons thereof. Skilled Labour-Tractor Driver has not any right of claiming permanency benefit of the said post or such posts by virtue of this appointment.
7. While leaving the job, Skilled Labour-Tractor Driver has to hand over the complete charge to a person nominated by the Principal Investigator and obtain No Objection Certificate from Principal Investigator.

8. The Skilled Labour-Tractor Driver will not be allowed to do any other work or to accept or hold another appointment with or without remuneration elsewhere.
9. Skilled Labour-Tractor Driver will devote whole time to the assignment given and will not be allowed to accept or hold another appointment paid or otherwise during the period.
10. Skilled Labour-Tractor Driver are full-time workers and are required to adhere to the administrative, financial and disciplinary regulations of University/Institute where the incumbent is working. Regular attendance of the Skilled Labour-Tractor Driver may be ensured by the concerned Co-PI/PI by keeping an attendance register.
11. Skilled Labour-Tractor Driver will have to work anywhere in the jurisdiction of MPKV as and when the need arises.
12. Skilled Labour-Tractor Driver has to perform all duties, responsibilities that will be assigned to him/her by the Principal Investigator/Co-Principal Investigator authorities as per the requirements of the project.
13. The Skilled Labour-Tractor Driver shall settle their claims within one month and in no case after the final settlement of the accounts of the scheme.
14. The Skilled Labour-Tractor Driver should execute the bond-on-bond paper of Rs. 100/- stating the terms and conditions are acceptable to him/her and will abide by the same as per the format provided from time to time.
15. All the other facilities right and financial benefits to permanent tractor driver of university will not applicable to appointed candidate.
