Intellectual property rights (IPRs) can be broadly defined as legal rights established over creative or inventive ideas. Such legal rights generally allow right holders to exclude the unauthorized commercial use of their creations/inventions by third persons. Intellectual Property is considered to be intangible asset and includes different categories such as Patents, Trademarks, Copyrights, Geographical Indications, Plant varieties etc. Intellectual Property Rights are the exclusive rights granted to the original creators to exploit and benefit from their creation. It provides legal protection and prevents others from utilizing the creation. The protections of Intellectual Property rewards the creativity of human mind thereby encourage individuals and business starts to invest in Research and Development activities. The economic incentives obtained from the protection of IP are expected to stimulate innovation and promote technological progress.

Lots of research being done in Mahatma Phule Krishi Vidyapeeth under various disciplines that can patents. These patents can be commercialized for revenue generation. Similarly, registration of Intellectual Property is important for improving ranking of Agriculture Universities. Also as per National Agricultural Education Accreditation Board, each agricultural university should have Intellectual Property Right & Commercialization Cell, so that the research work done, new designs and technologies developed, new plant varieties and new livestock breeds developed, etc can be patented and commercialized so as to increase revenue receipt of the University.

The Mahatma Phule Krishi Vidyapeeth, Rahuri has taken good initiative to protect the Intellectual Properties (IPs) developed by MPKV Rahuri for which the Memorandum of Understanding (MoU) was made with Great Mission Group Consultancy (GMGC), Pune on 20th December, 2018. The prime intention of making the MoU is to register Intellectual Properties (IPs) like technologies / trade mark / copy rights / designs / equipments / food, bakery and dairy products / biofertilizers / biopesticides / micronutrient formulations / post harvest products /
