The interview will not be undertaken without verification of documents.

**Terms and Conditions:**

1. Appointment is of purely on temporary basis and for six months subjected to the termination on closing of / termination of Revolving fund Operation and Maintenance of CASE New Holland Back Hoe Loader. The candidature of the candidate will be cancelled at any time without giving reason(s) thereof.
2. The selected candidate will be required to give an undertaking that he/she will not leave the assignment half way and shall complete the work in the prescribed time limit. In this regards the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per university rules.
3. The selection committee will interview only eligible candidates. The applicants will have to appear for the interview on scheduled date and time at their own cost.
4. If candidates are more, written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the Selection Committee.

The selected candidates will have to work at Revolving fund on "Operation and Maintenance of CASE New Holland Back Hoe Loader" under Workshop Superintendent, Central Automobile Workshop, MPKV, Rahuri as per the mandate of the project, at MPKV, Rahuri, or within its jurisdiction in the field for the entire term as full time worker and they will not be allowed to accept any other appointment/assignment during this period.
