
Verification of the Documents

- You need to bring all original documents in support of your claims in the application. You need to especially produce the original documents in support of eligibility (date of birth, educational qualifications along with the statement of marks and certificates), additional degree/ course/ training, additional experience and other claims.
- You need to report to the "Verification of Documents" desk upon arrival and produce the original documents for verification. If you are unable to produce the original documents in support of your minimum eligibility, you will be considered as ineligible for the interview.
- The Screening Committee qualified you based on the documents submitted from your end along with application. You need to produce the original documents in support of the qualification. If you fail to produce the original documents in support of eligibility, your interview call will be cancelled automatically.
- You are not allowed to submit documents other than those submitted with the applications during the "Verification of Document" process.
- Immediately after the document verification process is over, the Selection Committee will conduct the interview.

Other Conditions

- It is your responsibility to attend the interview on scheduled date and time and at scheduled place.
- You will have to attend the interview at your own cost and no TA/DA will be paid for attending the interview.
- It is to be noted that merely calling for the interview does not confirm the selection for the post and the candidate should not claim any appointment on the basis of this call letter.
- The post is purely on temporary basis for the specified period and the candidate is subjected to termination on the expiry of the period or coterminous with the scheme or by giving the notice of one month from either side.
- Canvassing in any form will make the candidate ineligible.
- You should bring photo identity along-with you that you need to produce during the "Verification of Document" Process.
- The interview call letter may not be sent to you by post; and hence you need to show the emailed letter to the "Verification of Document" desk; and you are advised not to delete this email.
