1. Appointment is of Purely contractual on temporary basis and for six months. The candidature of the candidate will be cancelled at any time without giving reason(s) thereof.
2. The selected candidate will be required to give an undertaking that he/she will not leave the assignment half way and shall complete the work in the prescribed time limit. In this regards the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per university rules.
3. The selection committee will interview only eligible candidates. The applicants will have to appear for the interview on scheduled date and time at their own cost.
4. If candidates are more, written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the Selection Committee.

The selected candidates will have to work at Farm Machinery Testing and Training Centre, AICRP on Farm Implement and Machinery, Dr. Annasaheb Shinde Government College of Agricultural Engineering and Technology, Mahatma Phule Krishi Vidyapeeth, Rahuri or within and outside state in the field /laboratory and office, as per the mandate of the centre, at MPKV, Rahuri, for the entire term as full time worker and they will not be allowed to accept any other appointment/assignment during this period.
