- b) Development of trained manpower in the field of plant breeding.
- c) To perform the product testing trials.

Nature of duties:

- a) Preparation of field layout for sowing of various research trials.
- b) Conducting the various field trials and recording the observations of various research trials from time to time in digital format.
- c) Looking and management of all field cultural practices in time.
- d) Procurement related to the various research trial work, analysis of data, report preparation, and maintaining all related documents.
- e) Any other work assigned by Maize Breeder from time to time.
- f) The place of work will be AICRP on Maize, Kasba Bawda, Kolhapur and the farm activities will be at Shenda park farm, Kuran farm and Bawda farm.

Terms and conditions for the contractual posts:
