Nature of Work:

1. To conduct the theory and practical / classes of concerned allotted courses.
2. To carry out the academic programme as directed by the MPKV, Rahuri.
3. To work as a counselor.
4. To work for examination/admission/cultural and sport cell.
5. To perform any other college duty as assigned by the Associate Dean of this college.

Terms and Conditions:

1. The appointment will be **purely temporary on contractual Basis** for maximum 11 months only or till the post is filled on regular establishment which is less.
2. The candidate has to submit the undertaking on Rs. 500/- bond paper for accepting all the terms and conditions prescribed.
3. The appointment shall automatically terminate any time on the joining of the person on regular establishment.
4. Any type of act or indiscipline behavior will be viewed seriously and assignment will be

terminated without any intimation to the candidate.

5. The candidate should have to apply on plain paper giving full details **as per enclosed proforma** to the "Associate Dean, Sant Muktai Government College of Agriculture, Muktainagar -425 306 Dist. Jalgaon (Old Muktainagar)" on or before **02/03/2026** with all required documents and payment deposit receipt **Rs. 500/- by post or by hand in office hours.**
6. Candidates should pay a processing fee of **Rs.500/- (Rs. 7. The eligible candidates will be interviewed by the **selection committee** approved by the University. The candidate shall have to attend an interview at their own cost. The candidate should produce all original documents at the time of interview on failing which candidature will be rejected.
8. The selected candidate must work full time and full term. She/He will not allow accepting **any other appointment during the contract period. She/He can only resign the post by giving one-month prior notice or by making payment of one month's fixed pay.**
9. This contract comes to an end functionally after completion of tenure period and if the candidates have not continued for next semester, he should have to complete his work on his own cost and no remuneration will be paid to her/him.
10. Appointment of selected candidate for the said post will be tenure appointment and liable to be terminated at any time without assigning any reason thereof and candidate shall not have any right to claim permanency benefit in lieu of this contractual appointment.


