## Broad objectives of the project

- 1. Development of early maturing and high yielding Bt cotton varieties
- 2. To develop the seed production and dissemination system for improved Bt cotton Varieties.
- 3. To develop Straight Bt Cotton Variety High density planting system model for farmers.

## Nature of work:

The Young Professional (YP-II) and Laboratory Attendant will be responsible for

1. Preparation of field layout for sowing of trials.

2. Conducting large scale field trial and recording of the field data from time to time in digital format as per the project objectives.

- 3. Looking after all the field cultural practices in timely manner.
- 4. Laboratory work related to use of marker assisted selection.
- 5. Procurement related to the project work, analysis of the data, preparing progress report of the project,

writing research articles and maintaining all the project related documents.

6. Any other work assigned by the Principal Investigator from time to time.

## Terms and conditions-

- 1. The value of remuneration for Young Professional (YP-II) is Rs.35,000/- and Laboratory Attendant (LA) is Rs. 15,000/- fixed per month.
- 2. The minimum age will be 21 years and maximum age 45 years for YP-II and LA.
- 3. The placement of YP-II and LA in the scheme/project will be made on contract basis initial for six months, which can be continued on six monthly basis/the date of termination of the project/scheme depending on the satisfactory progress/performance.
- 4. Candidates called for the interview for the position of YP-II and LA will not be entitled for TA/DA.
- 5. The position will be terminated on completion of the terms of the scheme/ project whichever is earlier. University holds no responsibility for his/her regularization/appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporarily, time bound arrangement on co-terminus basis with the project.
- 6. The appointment of YP-II and LA will be terminated at any time by issue of 24 hours' notice if the YP-II and LA is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct.
- 7. YP-II and LA will be under the administrative control of the concerned PI Cotton Breeder, Cotton Improvement Project, MPKV, Rahuri.
- 8. Regular attendance may be ensured by the concerned PI by keeping the attendance register.
- 9. The YP-II and LA shall settle their claim within one year of leaving scheme and no claim will be entertained after one year of leaving or termination of his/her service.
- 10. The research work done by the YP-II and LA will be the property of the university and the YP-II and LA will have no control or right on the same. The contribution in research work can accordingly be acknowledged/included in the research papers after the prior permission from PI.
- 11. YP-II and LA will devote their whole time to the assignment given to them and they will not be allowed to accept or hold another appointment paid or otherwise during that period.
- 12. YP-II and LA engaged in the project/scheme while applying for any position/ post elsewhere have to obtain NOC from his/her present PI.
- 13. While leaving the job, YP-II and LA has to hand over the charge to his/her PI and obtain NOC from PI.

- 14. Candidate shall not leave the project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
- 15. The candidate has to perform all duties, responsibilities that will be assigned to him/her by the PI/Co PI/Superior Authority as per the requirement of the project.
- 16. The candidate should apply on plain paper giving full details as per the enclosed proforma to the Cotton Breeder, Cotton Improvement Project, Mahatma Phule Krishi Vidyapeeth, Rahuri- 413 722, Dist. Ahmednagar, Maharashtra on or before 28.08.2023 (17.00 hrs.). Applications received after last date/postal delay will not be considered.
- 17. The eligible candidate will be interviewed by Selection Committee.
- The selected candidate will have to work at Cotton Improvement Project, MPKV, Rahuri for entire term as full-time worker.
- 19. The notification does not mean that the post will necessarily be filled in. The discretionary powers will rest with Selection Committee constituted for the purpose. The appointment of the selected candidate for the said post shall be a tenure appointment and likely to be terminated at any time without assigning any reason thereof and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of appointment.
