









- 6. In case, if the item/material supplied found defective at a later stage, the same shall be replaced immediately at free of cost.
- 7. The invoice shall contain the break-up of GST and should reflect the same price mentioned in the quotation.
- 8. 100% payment shall be made against delivery of material in good condition.
- 9. Supplier should quote the rates with make/brand and Catalogue No. of offered item failing which the quotation will be rejected.
- 10. Certificate of Analysis (COA) wherever applies be provide at the time of delivery alongwith material.
