## Terms and Conditions -

- 1. Please quote the rates inclusive of all taxes and FOR destination.
- 2. Rate quoted should be valid for at least 90 days.
- 3. Individual certificate of analysis (COA) for each item needs to be provided with the material.
- 4. The supplier shall enclose the authorization certificate, in case of other than OEM.
- 5. All the above items should have ISO 17034 traceability and documentary evidence for the same must be provided at the time of delivery failing which payment will not be made and supplier have to collect the material with free to cost.
- 6. The items shall be from latest batch of production and shall be delivered with a minimum shelf life of two years from the date of delivery.
- 7. In case, if the item/material supplied to be defective at a later stage, the same shall be replaced immediately at free of cost.
- 8. The invoice shall contain the break-up of GST and should reflect the same price mentioned in the quotation.
- 9. 100% payment shall be made against delivery of material in good condition.
- 10. The price may be quoted for 50 mg package. If this packing is not available, then the price should be quoted for the next packing size and the prices will be compared based on the standard requirement of 50mg/100mg.
- 11. Supplier should quote the rates with make/brand and catalogue No. of offered item failing which the quotation will be rejected.
- 12. The supplier will be fully responsible for any loss in transit and will also be responsible for safe delivery of the goods/ stores in good conditions at Pesticide Residue Laboratory, MPKV, Rahuri.
- 13. The number of items may increase or decrease upto 25% at the time of award of purchase order depending on the actual need/requirement of PRL, MPKV, Rahuri.
- 14. The supplier must have a registered office within the jurisdiction of India and proof for same needs to be attached (PAN, GST details).
- 15. This office will not be responsible for postal delay if any. The quotations received after due date will not be considered.

- The supplier should provide the material within 4-6 weeks from the date of issue of purchase order.
