Applications are invited for filling up the following temporary post on purely contractual YP-I (01 Nos) basisviz., Young Professional and Young Professional (01 Nos) in the Ad-hoc project 'Development of high yielding & nutritive rabi sorghum varieties suitable for mechanical harvesting' under AICRP on Sorghum Improvement Project, MPKV, Rahuri to assist in development of nutritional, high yielding, non lodging and biotic and abiotic tolerant varieties and Tractor Operated Sorghum Harvester. At the time of interview, the original and attested photocopies of concern documents should be produced by the candidate for the verification.

Term and Conditions:

- 1. The value of remuneration for Young Professional (YP-I) is Rs.25,000/- (fixed) per month and Young Professional (YP-II) is Rs.35,000/- (fixed) per month. No House Rent Allowance (HRA) will be paid to YP-I and YP-II.
- 2. The minimum age will be 21 years and maximum age 45 years for YP-I and YP-II

- 3. The placement of YP-I and YP-II in the Ad-hoc project will be made on purely contractual on temporary basis initial for six months, which can be continued on six monthly basis/the date of termination of the Ad-hoc project depending on the satisfactory progress/ performance of the selected candidate.
- 4. Candidates called for the interview for the position of YP-I and YP-II will not be entitled for
- 5. The position will be terminated on completion of the terms of the *Ad-hoc* project whichever is earlier. University holds no responsibility for his/her regularization/appointment by absorption or otherwise against any regular post on termination of the *Ad-hoc* project as it is purely contractual on temporary basis, time bound arrangement on co-terminus basis with the *Ad-hoc* project.
- 6. The appointment of YP-I and YP-II will be terminated at any time by issue of 24 hours notice if the YP-I and YP-II is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct.
- 7. YP-I and YP-II will be under the administrative control of the concerned Principal Investigator and Senior Sorghum Breeder, Sorghum Improvement Project, MPKV, Rahuri.
- 8. Regular attendance may be ensured by the concerned PI by keeping the attendance register.
- 9. YP-I and YP-II shall settle their claim within one year of leaving Ad-hoc Project and no claim will be entertained after one year of leaving or termination of his/her service.
- 10. The research work done by the YP-I and YP-II will be the property of the university and the YP-I and YP-II will have no control or right on the same. The contribution in research work can accordingly be acknowledged/ included in the research papers after the prior permission from PI.
- 11. YP-I and YP-II will devote their whole time to the assignment given to them and they will not be allowed to accept or hold another appointment paid or otherwise during that period.
- 12. YP-I and YP-II engaged in the *Ad-hoc* project while applying for any position/ post elsewhere have to obtain NOC from his/her present PI.
- 13. While leaving the job, YP-I and YP-II has to hand over the charge to his/her PI and obtain NOC from PI.
- 14. Candidate shall not leave the *Ad-hoc* project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
- 15. The candidate has to perform all duties, responsibilities that will be assigned to him/her by the PI/Co-PI(s)/ Superior Authority as per the requirement of the *Ad-hoc* project.
- 16. The candidate should apply on plain paper giving full details as per the enclosed proforma to the 'Principal Investigator and Senior Sorghum Breeder, Sorghum Improvement Project, Mahatma Phule Krishi Vidyapeeth, Rahuri- 413722, Dist. - 17. The eligible candidate will be interviewed by Selection Committee.
- 18. The selected candidate YP-I will have to work at AICRP on Sorghum, MPKV, Rahuri for entire term while YP-II will have to work at AICRP on Farm Implements Machinery, Dr. ASCAET, MPKV, Rahuri.
