## Terms and conditions-

- 1. It is the responsibility of the candidate to submit the application and to attend the interview on scheduled date and time and at a scheduled place.
- 2. The candidate will have to attend the interview at his/her own cost and no TA/DA will be paid for attending the interview.
- 3. The minimum age will be 21 years and maximum age 40 years for YP-I.

- 4. The placement of YP-I in the scheme/project will be made on contract basis initial for six months, which can be continued on six monthly basis/as per the requirement in the project depending on the satisfactory progress/performance.
- 5. The appointment of YP-I will be terminated at any time by issue of 24 hours' notice if the YP-I is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct.
- 6. YP-I will be under the administrative control of the Chief Agronomist, AICRP on IFS, MPKV, Rahuri
- 7. The candidate should bring photo identity which needs to be produced during the "Verification of Document" Process.
- 8. The value of remuneration for Young Professional (YP-I) is Rs.30,000/- consolidated per month.
- 9. Regular attendance may be ensured by the Chief Agronomist, AICRP on IFS, MPKV, Rahuri by keeping the attendance register.
- 10. Candidate have to collect data from farmers field, make base line survey of each selected farmers, entry of online data so also conduct training programme on farmers field.
- 11. YP-I will devote their whole time to the assignment given to them and they will not be allowed to accept or hold another appointment paid or otherwise during that period.
- 12. YP-I engaged in the project/scheme while applying for any position/ post elsewhere have to obtain NOC from the Chief Agronomist, AICRP on IFS, MPKV, Rahuri
- 13. While leaving the job, YP-I has to hand over the charge to Principle Investigator(Pilot project on Crop Diversification and Chief Agronomist, AICRP on IFS, MPKV, Rahuri
- 14. Candidate shall not leave the project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
- 15. That, the candidate has to perform all duties, responsibilities that will be assigned to him/her by Principle Investigator( PPCD) and Chief Agronomist, AICRP on IFS, MPKV, Rahuri
- 16. The eligible candidate will be interviewed by Selection Committee.
- 17. The notification does not mean that the post will necessarily be filled in. The discretionary powers will rest with Selection Committee constituted for the purpose. The appointment of the selected candidate for the said post shall be a tenure appointment and likely to be terminated at any time without assigning any reason thereof and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of appointment.
