The following contractual post (purely on temporary basis) is to be filled in the Rashtriya Krishi Vikas Yojana project (RKVY) entitled "Solar Powered Central Pivot Irrigation System (SPCPIS) for Climate Smart Agriculture" under Interfaculty Department of Irrigation Water Management, Mahatma Phule Krishi Vidyapeeth, Rahuri. This project has aims to optimize the parameters required for efficient operation of solar powered central pivot irrigation system for major crops grown in Maharashtra, demonstrating the utility of solar powered central pivot irrigation system for water and energy saving for various crops, to enhance the seed production of major crops by providing protection irrigations, training to the local youths for operation and maintenance of the solar powered pivot irrigation system and evaluation of the utility of this system.

- 1) **SRF** - The Upper age limit will be 35 years for men and 40 years for women.
- 2) **Data Entry Operator** – the minimum age limit will be 35 years for men and 40 years for women

Conditions

- a) It is the responsibility of the candidate to submit the application and to attend the interview in person on scheduled date and time as communicated by email/text message.
- b) The post is purely on a temporary basis for the specified period stated in this notification and the candidate is subjected to termination on the expiry of the period or the project or by giving the notice of one month from either side.
- c) Canvassing in any form will make the candidate ineligible.
- d) The candidate should bring photo identity which needs to be produced during the "Verification of Document" Process or interview.
- e) It is to inform to note all the terms and conditions of the temporary employment as stated below.

Terms and Conditions:

1. Appointment is of purely on temporary basis and for six months subjected to the termination on closing of / termination of RKVY project. The candidature of the candidate will be cancelled at any time without giving reason(s) thereof.
2. The selected candidate will be required to give an undertaking that he/she will not leave the assignment half way and shall complete the work in the prescribed time limit. In this regards the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per university rules.
3. The selection committee will interview only eligible candidates. The applicants will have to appear for the interview on scheduled date and time at their own cost.

4. If candidates are more, written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the Selection Committee.
5. The selected candidates will have to work at "Rashtriya Krishi Vikas Yojana" under Interfaculty Department of Irrigation Water Management, MPKV, Rahuri or within its jurisdiction in the field /laboratory and office, as per the mandate of the project, at MPKV, Rahuri, for the entire term as full time worker and they will not be allowed to accept any other appointment/assignment during this period.
6. The notification does not mean that all the posts will be necessarily filled. The discretionary power will rest with the Selection Committee constituted for the purpose.
7. The appointment of the selected candidate for the said post shall be a tenure appointment and purely on temporary basis (six months) and likely to be terminated at any time without assigning any reason thereof and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of this appointment.
8. Actual working place of the candidate will be Central Campus, MPKV, Rahuri. However, as a part of duty, the candidate will have to perform field, research, extension and office duties besides the work of survey, demonstrations on farmer's fields, training programmes, etc.
