NOTIFICATION

The following contractual post (purely temporarily) is to be filled in the project entitled, "Standardizing Drone spraying protocols for various inputs in selected field crops (Soybean, Pigeonpea, Wheat, Chickpea, Sugarcane)" under the Centre of Excellence on Digital Technologies for Smart and Precision Agriculture (CoE-DTSPA), Department of Agricultural Engineering, Mahatma Phule Krishi Vidyapeeth, Rahuri. This project aims to standardize spraying protocols for various chemicals, fertilizers, pesticides, nutrients etc., with the use of drones for select crops namely (Sugarcane, Chickpea, Soybean, Pigeonpea, and Wheat) including the selection of drone spraying accessories; and validate above activities through field experiments.

- 1) Young Professional II (YP) The minimum age under YP will be 21 years and a maximum 45 years.
- 2) Field Assistant The Upper age limit will be 35 years for men and 40 years for women.

Conditions

- a) It is the responsibility of the candidate to submit the application and to attend the interview in person on the scheduled date and time as communicated by email/text message.
- b) The post is purely on a temporary basis for the specified period stated in this notification and the candidate is subjected to termination on the expiry of the period or the project or by giving the notice of one month from either side.
- c) Canvassing in any form will make the candidate ineligible.
- d) The candidate should bring a photo identity which needs to be produced during the "Verification of Document" Process or interview.
- e) This is to inform to note all the terms and conditions of the temporary employment as stated below.

Terms and Conditions:

- 1. Appointment is purely on temporary basis and for 11 months subjected to the termination on closing of / termination of project. The candidature of the candidate will be cancelled at any time without giving reason(s) thereof.

- 3. The selection committee will interview only eligible candidates. The applicants will have to appear for the interview on the scheduled date and time at their own cost.
- 4. If candidates are more, the written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the Selection Committee.
- 5. The selected candidates will have to work at "The Centre of Excellence on Digital Technologies for Smart and Precision Agriculture (CoE-DTSPA), Mahatma Phule

- per the mandate of the project, at MPKV, Rahuri, for the entire term as a full-time worker and they will not be allowed to accept any other appointment/assignment during this period.
- 6. The notification does not mean that all the posts will be necessarily filled. The discretionary power will rest with the Selection Committee constituted for the purpose.
- 7. The appointment of the selected candidate for the said post shall be a tenure appointment and purely temporary (11 months) and likely to be terminated at any time without assigning any reason thereof and the candidate shall not have any right to claim permanency benefit of the said post or such posts by virtue of this appointment.
- 8. Actual working place of the candidate will be Central Campus, MPKV, Rahuri. However, as a part of duty, the candidate will have to perform field, research, extension and office duties besides the work of survey, demonstrations on farmer's fields, training programmes, etc.
