Applications are invited for following temporary post on contractual basis in the Scheme 'Monitoring of Pesticide Residues at National Level' under 'All India Network Project on Pesticide Residues', Department of Entomology, MPKV, Rahuri. The interested candidates are encouraged to apply in the prescribed format (provided in this notification) by submitting the application along with the related self-attested certificates/documents by post or in person to the Head, Department of Entomology, MPKV, Rahuri so as to reach on or before 12 January, 2024 (up to 6.00 pm).

The applications will be scrutinized for the eligibility and only short-listed candidates will be called for the interview. No additional documents other than those submitted with the application will be accepted separately either before the last date, after the last date or at the time of interview.

The date of interview will be communicated to eligible candidates separately by email/text message. However, the candidates are also advised to visit regularly the website www.mpkv.ac.in for any updates.

Terms and conditions-

1. The value of remuneration for Lab Attendant (LA) is Rs. 14,000/- consolidated per month.
2. The minimum age will be 21 years and maximum age will be 40 years.
3. The placement of candidate in the scheme/project will be made on contract basis initially for six months or upto 31-03-2024 as communicated by sanctioning authority.
4. The appointment can be continued on six monthly basis up to the date of termination of the project/scheme depending on the satisfactory progress/performance.

5. Candidates called for the interview for the position of LA will not be entitled for TA/DA.
6. The appointment will be terminated on completion of the tenure of the scheme/ project. DAC/ICAR/State Govt. /University holds no responsibility for his/her regularization/ appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporarily, time bound arrangement on co-terminus basis with the project.
7. The appointment of LA will be terminated at any time by issuing 24 hours notice if the LA is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct.
8. The candidate will be under the administrative control of the concerned PI and regular attendance will be ensured by the concerned PI by keeping the attendance register.
9. The LA shall settle their claims within six month of leaving project/scheme and no claim will be entertained after six month of leaving or termination of his/her service.
10. The candidate will devote his whole time to the assignment given to him and he will not be allowed to accept or hold another appointment paid or otherwise during that period.
11. Candidate shall not leave the project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
12. The candidate has to perform all duties, responsibilities that will be assigned to him/her by the PI/Residue Analyst/Superior Authority as per the requirement of the project.
13. The selected candidate will have to work at Pesticide Residue Laboratory, Department of Entomology, MPKV, Rahuri for entire term as full time worker.
14. The notification does not mean that the post will necessarily be filled in. The discretionary powers will rest with Selection Committee constituted for the purpose. The appointment of the selected candidate for the said post shall be a tenure appointment and likely to be terminated at any time without assigning any reason thereof and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of appointment.
