Activity profile of the project:

Activity 1: Conduct training programs during season, pre and post season for master trainers / farmers on Cotton BMPs in production, ginning and processing fields

Activity 2: Establishment of action learning sites at research center during the cotton season to facilitate Farmer Field Schools (both physical & virtual) at different crop phenological stages

Activity 3: Development of Information, Education and Communication (IEC) products (text, audio, video, animations) and dissemination via ICT extension tools/ social media channels

Activity 4: Issue 'Voice messages' to mobiles of registered farmers at weekly intervals during the cotton season

Activity 5: Documentation of Farmer success stories

Terms and conditions-

1. The value of remuneration for Young Professional (YP-I) is Rs.25, 000/-.
2. The minimum age will be 21 years and maximum age 45 years for YP-I.
3. The placement of YP-I in the scheme/project will be made on contract basis initial for six months, which can be continued on six monthly basis/the date of termination of the project/scheme depending on the satisfactory progress/performance.
4. Candidates called for the interview for the position of YP-I will not be entitled for TA/DA.
5. The position will be terminated on completion of the terms of the scheme/ project whichever is earlier. University holds no responsibility for his/her regularization/appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporarily, time bound arrangement on co-terminus basis with the project.
6. The appointment of YP-I will be terminated at any time by issue of 24 hours' notice if the YP-I is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct.
7. YP-I will be under the administrative control of the concerned PI Cotton Breeder, Cotton Improvement Project,MPKV, Rahuri.
8. Regular attendance may be ensured by the concerned PI by keeping the attendance register.
9. The YP-I shall settle their claim within one year of leaving scheme and no claim will be entertained after one year of leaving or termination of his/her service.
10. The research work done by the YP-I will be the property of the university and the YP-I will have no control or right on the same. The contribution in research work can accordingly be acknowledged/included in the research papers after the prior permission from PI.
11. YP-I will devote their whole time to the assignment given to them and they will not be allowed to accept or hold another appointment paid or otherwise during that period.
12. YP-I engaged in the project/scheme while applying for any position/ post elsewhere have to obtain NOC from his/her present PI.
13. While leaving the job, YP-I has to hand over the charge to his/her PI and obtain NOC from PI.
14. Candidate shall not leave the project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
15. The candidate has to perform all duties, responsibilities that will be assigned to him/her by the PI/Co PI/Superior Authority as per the requirement of the project.
16. 17. The eligible candidate will be interviewed by Selection Committee.

18. The selected candidate will have to work at Cotton Improvement Project, MPKV, Rahuri for entire term as full-time worker.
