Terms and conditions-

1. The candidate will have to attend the interview at his/her own cost and no TA/DA will be paid for attending the interview.
2. The minimum age will be 21 years and max age 40 years for application for the post of YP-II.
3. The placement of YP-II in the scheme/project will be made on contract basis initial for the period of six months, which can be continued further six monthly basis/as per the requirement in the project depending on the satisfactory progress/performance.
4. The appointment of YP-II will be terminated at any time if the he is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or misconduct.
5. The candidate should bring valid photo identity card at the time of interview for "Verification of Document" Process.
6. **Candidate have to collect data from farmers field, make base line survey of each Selected farmers, entry of online data and also conduct the training programmes on farmers field.**
7. YP-II will not accept or hold another appointment/ assignment during the period of project.
8. While leaving the job, YP-II has to hand over the charge to Principle Investigator, MM-III i.e. to Agrometeorologist, AICRP on Agromet, DLA, ZARS, Solapur

9. Candidate shall not leave the project during and or in the middle of the tenure. Further, however, if he/she intends to do so he/she has to give one month notice in writing in advance or remit the amount of one month salary.
