### NOTIFICATION

Applications are invited for following temporary post on contractual basis in the project 'Monitoring of Pesticide Residues at National Level' functioning at 'All India Network Project on Pesticide Residues & Contaminants', Department of Entomology, MPKV, Rahuri. #### **Terms and conditions-**

1. Age Limit: The minimum age for Young Professional-II (YP-II) shall be 21 years and the maximum age shall be 45 years.
2. The placement of YP-II in the scheme/project will be made purely on a contract basis. The initial appointment is for six months or until the termination of the project whichever is earlier.
3. The appointment may be extended for **six-month periods** until the termination of the project, subject to satisfactory performance and age criteria.
4. Candidates called for the interview will not be entitled to TA/DA.
5. The appointment will be terminated automatically upon completion of the project tenure. DAC/ICAR/State Govt./University holds no responsibility for regularization

or absorption into a regular post. This is a purely temporary, time-bound arrangement co-terminus with the project.

6. The appointment may be terminated at any time with 24 hours' notice if the YP-II is found negligent in their work, guilty of gross negligence, or found to have committed grave misconduct.
7. The selected candidate will be under the administrative control of the concerned Principal Investigator (PI).
8. Regular attendance shall be monitored and ensured by the concerned PI through an attendance register.
9. Selected candidates must settle all claims within six months of leaving the project. No claims will be entertained after this period.
10. All research work conducted by the YP-II will be the property of the University. The YP-II shall have no rights over the same. Research contributions may be acknowledged or included in papers only after obtaining prior permission from the competent authority.
11. The selected candidate shall devote their full time to the assigned tasks and is not permitted to accept or hold any other appointment (paid or otherwise) during the tenure.
12. Candidates wishing to apply for other positions during their tenure must obtain an NOC from their PI.
13. Upon resignation or completion of tenure, the YP-II must hand over charge and obtain an NOC from the PI.
14. Candidates should not leave the project mid-tenure. However, if a candidate intends to leave, they must provide one month's written notice or remit an amount equal to one month's salary.
15. The candidate must perform all duties and responsibilities assigned by the PI, Residue Analyst, or Superior Authority as required by the project.
16. Candidates should apply on plain paper providing full details as per the enclosed proforma, along with self-attested copies of all documents. Applications must reach the Head, Department of Entomology, MPKV, Rahuri-413 722, Dist. Ahilyanagar, Maharashtra, on or before **18-02-2026 (18.00 hrs)**. Late applications or those delayed by the post will not be considered.
17. Eligible candidates will be interviewed by a Selection Committee. Candidates must bring original certificates (from Matriculation onwards) for verification.
18. The selected candidate will work full-time at the Pesticide Residue Laboratory, Department of Entomology, MPKV, Rahuri, for the entire term.
19. This notification does not guarantee that the post will be filled. Discretionary powers rest with the Selection Committee.



20. The appointment is a tenure-based position and may be terminated at any time without assigning any reason. The candidate shall have no right to claim permanency or benefits by virtue of this appointment.
