

The postal delay will not be considered. Applications received through e-mail will not be considered.
3. The candidates should apply separately for each post.
4. If the numbers of candidates applied are more in number, the written test will be taken for screening the candidates and after screening selected candidate will be interviewed by the selection committee.
5. The eligible candidates only will be interviewed by Selection Committee in person. The candidates have to attend interview on his/her own cost. No TA/DA and accommodation will be provided for appearing in the interview.
6. The candidate has to produce all original documents at the time of interview failing which his/her candidature will be rejected.
7. The selected candidates will be required to give an undertaking that he/she will not leave the assignment halfway and shall complete the work in prescribed time limit. In this regards, the candidate selected for the post will have to execute bond on stamp paper of Rs. 100/- as per university order.
8. The selected candidates will have to work at RSJRS, Kolhapur or within its jurisdiction in the field /laboratory and office, as per the mandate of the projects for the entire term as full time worker and he/she will not be allowed to accept any other appointment/assignment during this period.
9. The notification does not mean that all the posts will necessarily be filled. The discretionary power will rest with the Selection Committee constituted for the purpose.
