#### Terms and Condition -

- 1. The value of remuneration as per above is consolidated per month.
- 2. The upper age limit for JRF will be 35 year for men and 40 year for women.
- 3. The placement of JRF in the scheme/project will be made on contract basis which can be continued on six monthly basis upto the date of termination of the project/scheme depending on the satisfactory progress/performance.
- 4. Candidates called for the interview for the position of JRF will not be entitled for TA/DA.
- 5. The fellowship will be terminated on completion of the terms of the scheme/ project whichever is earlier. DAC/ ICAR/ Institutes/ University holds no responsibility for his/her regularization/ appointment by absorption or otherwise against any regular post on termination of the project as it is purely temporarily, time bound arrangement on co-terminus basis with the project.
- 6. The appointment of JRF will be terminated at any time by issue of 24 hours notice if the JRF is found to be negligent in his/her work or found guilty of gross negligence in his/her duties or of grave misconduct.
- 7. JRF will be under the administrative control of the concerned Assistant Nematologist and Head, Department of Agril. Entomology, MPKV, Rahuri.

8. Regular attendance may be ensured by the concerned Assistant Nematologist by keeping the attendance register.

9. The JRF shall settle their claim within one year of leaving fellowship/scheme and no claim will

be entertained after (one year) leaving or termination of his/her service.

10. The research work done by the JRF will be the property of the Project and the JRF will have no control or right on the same. The contribution in research can accordingly be acknowledged/included in the research papers after the prior permission from Head of the Department.

11. JRF will devote their whole time to the assignment given to them and they will not be allowed to

accept or hold another appointment paid or otherwise during that period.

12. JRF engaged in the project/scheme while applying for any position/post elsewhere have to obtain NOC from his/her present Assistant Nematologist.

13. While leaving the job, JRF has to hand over the charge to his/her Assistant Nematologist and

obtain NOC form Head, Department of Entomology, MPKV, Rahuri.

14. Candidate shall not leave the project during and or in the middle of the tenure. Further however, if he/she has to give three months notice in writing in advance or remit the amount of one month salary.

15. That, the candidate has to perform all duties, responsibilities that will be assigned to him/her by

the Assistant Nematologist /Superior Authority as per the requirement of the project.

16. The candidate should apply on plain paper giving full details as per the enclosed proforma to the Head Department of Agril. Entomology, Mahatma Phule Krishi Vidyapeeth, Rahuri- 413 722, Dist. Ahmednagar, Maharashtra on or before 16.12.2022. The candidates already employed should apply through their employer. Applications received after last date/postal delay will not be considered.

17. The eligible candidate will be interviewed by Selection Committee. The selected candidate will have to work at 'AICRP on Nematodes in Agriculture' under the Department of Agril.
