1. The placement of Young Professional - I will be made on contractual and purely temporary basis for six months.
2. Candidates called for the interview for the position of Young Professional - I will not be entitled for TA/DA.
3. He / She shall perform all duties regarding preparation of letters, conduction of trials compilation of reports, office PPTs, other related ministerial work.
4. He / She should fit for field work.
5. The appointment of Young Professional - I will be terminated at any time by issue of 24 hours notice is found to be negligent in his / her work or found guilty of negligence in his / her duties or of grave misconduct.
6. Young Professional - I will be under administrative control of Horticulturist, AICRP on Arid Zone Fruits, Department of Horticulture, MPKV., Rahuri
7. Regular attendance may be ensured by the concerned in charge by keeping the attendance register.
8. Young Professional - I will devote their whole time to the assignment given to him/her and he/she will not be allowed to accept or hold another appointment paid or otherwise during that period.
9. Candidate shall not leave the scheme during and or in the middle of the tenure. Further, however, if he / she intends to do so he / she has to give one month notice in writing in advance or refund one month salary.
