The following Indian Council of Agricultural Research guidelines are applicable for Adjunct Faculty:

- 1. The Adjunct faculty shall deliver lectures and render help and guidance pertaining to the education and research programme, especially help in developing research projects and providing guidance to scientist of the University.
- 2. Adjunct faculty shall be treated as University Guest at the Agricultural University (AU) and should be provided free University accommodation.
- 3. The honorarium to the Adjunct Faculty shall be generally @ Rs.1,000/- per day stay.
- 4. The Adjunct Faculty shall deliver at least 18 lectures in a maximum of two spells and spend at least 15 days in a year at the University campus or its constituent colleges.

The Adjunct Faculty will be paid TA and DA as per State Government Resolution (Finance Department) No. Travel-1013/Pra. Kra. 3/service-5, dated 2nd May, 2013 and for this the expenditure will be met from the sanctioned grants of SAU's of respective college / department.
