Corrigendum

The Managing Director, Maharashtra Bamboo Development Board, Nagpur (Govt. of Maharashtra) vide letter under reference at Sr. No. 1 had sanctioned the "Bamboo Plantation Project" at Central Campus, MPKV, Rahuri during 2018-19 to 2020-21 and University had issued the resolution referred at Sr. No. 2. As per university request the Managing Director, Maharashtra Bamboo Development Board, Nagpur (Govt. of Maharashtra) had extended the project for one year i.e. 2021-22 vide letter referred at Sr. No. 3.

On approval accorded by Executive Council referred at Sr. No. 4 Hon'ble Vice Chancellor, MPKV, Rahuri had accorded reappropriation & utilization of unspent balance funds amounting to Rs.1,11,80,118/- (Rs. One crore eleven lakh eighty thousand one hundred eighteen only) under Bamboo Plantation Project for the year 2023-24 and University has issued the resolution referred at Sr. No. 5.

Due to the implementation of code of conduct of the Lok Sabha election from March 2024, some funds of AICRP Agro forestry and State Level Biotechnology Centre could not be utilized. Hence, total funds of Rs.25,80,548/- is remained unspent on 31stMarch, 2024.

Due to very short period for purchasing of laboratory instruments on GeM portal State Level Biotechnology Centre has not utilized their unspent balance under non-recurring. Hence, total funds Rs.19,45,784.00 (Rs. Nineteen lakh forty five thousand seven hundred eighty four only) has been remain unspent on 31st March, 2025.

On approval accorded by Executive Council vide minutes under reference at Sr. No. 8 Hon'ble Vice Chancellor, MPKV, Rahuri is pleased to accord utilization of unspent balance funds of Rs.19,45,784.00 (Rs. Nineteen lakh forty five thousand seven hundred eighty four only) in Bamboo Plantation Project (Tissue Culture), for one more year *i.e.* 2025-26. The details of unspent balance funds under State Level Biotechnology Centre are given in *Annexure A*.

Dr. R. H. Kolse, I/C AICRP on Agro forestry, MPKV, Rahuri will act as Principal Investigator of this project and Dr. A. R. Aher, Assistant Professor of Agril. Botany will act as Co-Principal Investigators of this project. The Drawing and Disbursing Officer for this project will be Associate Professor of Botany MPKV, Rahuri. The administrative and technical control of the said project shall rest with the Head, Department of Agril. Botany. The overall control of this project shall rest with the Director of Research, MPKV, Rahuri will remain same.



Apart from the aforesaid changes, all the matters mentioned in the University resolution referred at Sr. No. 2 and 5 shall remain applicable as it is.
