Ministry of Agriculture and Farmers Welfare, Department of Agriculture and Farmers Welfare, New Delhi (Government of India) has approved continuation of Centrally Sponsored Schemes namely Pradhan Mantri Rashtriya Krishi Vikas Yojana (RKVY) and Krishonnatti Yojana (KY) from 01.04.2021 to 31.03.2026. The National Food Security Mission (NFSM) has been renamed as National Food Security & Nutrition Mission (NFSNM) and has been brought under Krishonnatti Yojana (KY). Also, the erstwhile Sub-Mission on Seed & Planting Material (SMSP) is subsumed under NFSNM as NFSNM: Seed Components. The mission is going to implement in all the states including Maharashtra.

The administrative and technical control of the said project shall rest with the Chief Scientist (Seed), Seed Cell MPKV, Rahuri. The overall control of this project shall rest with the Director of Research, MPKV, Rahuri will remain same.
